## **PROCESS INFORMATION:**

**Submission Requirement:** An application for a Conditional Use Permit shall be filed with the Development Compliance Officer. Such applications shall contain all the information required on this form and must be determined to be complete by the Development Compliance Officer prior to advancing it through the approval process.

Public Notification: This is a quasi-judicial process that requires a public hearing.

Review Process: Conditional Use Permits are for certain land uses that, because of unique characteristics or potential impacts on adjacent land uses, are not permitted in zoning districts as a matter of right. These uses may be permitted through the issuance of a Conditional Use Permit (CUP) after ensuring that the use complies with the CUP approval criteria. No inherent right exists to receive a CUP. Such authorization must be approved under a specific set of circumstances and conditions. Each application and situation is unique and may be subject to specific requirements to mitigate the impacts of the proposed use. A Conditional Use Permit must be granted in accordance with the procedures set forth in Article 7 of the Wilson's Mills Development Ordinance (WMDO). For a detailed list of uses requiring a Conditional Use Permit, please refer to Article 10.2 of the WMDO.

## **FILING INSTRUCTIONS:**

Every applicant for a Conditional Use Permit is required to meet with the Development Con Officer in a pre-application conference prior to the submittal of a formal application.
