ABOUT THE PARK

Located at [988 Powhatan Road](#), the Town's community park is open to the public daily from dawn to dusk. The park offers a welcoming outdoor space for residents and visitors to relax, play, and enjoy time together. Park amenities include a large playground structure and swing sets for children, two chalk pads, cornhole boards, picnic tables, and two park grills (available for public use when the park shelter is not reserved).



The park is also home to the Caren M. Triplett Memorial Bark Park, a spacious, two-section dog park designed for dogs of all sizes, with separate areas for small dogs and large dogs. Scroll below to learn more about the Bark Park and its features.

In addition, the park hosts the [Clayton Rugby Football Club](#), which currently utilizes three rugby fields—one fully operational with two additional fields under development. More information about Youth Rugby at Wilson's Mills can be found below.

PARK SHELTER RENTALS



The park shelter is available for renters to host birthday parties, family gatherings, or community-related events. The rental is specifically for the larger space under the shelter, not the smaller space where the public restrooms are available. The shelter is available for rental during normal operating hours, dawn to dusk (8am-8pm).

RENTAL RATES

In-Town Residents	\$15 per hour (2 hour minimum) <i>\$100 full day rate (more than 6 hours)</i>
Out-of-Town Residents	\$30 per hour (2 hour minimum) <i>\$200 full day rate (more than 6 hours)</i>

Shelter Amenities include:

<p>Two electrical outlets, each with two plugs, one located on the back wall of the shelter and one on the front post closest to the parking area.</p>	

Please note: The playground is not included in the rental and will remain open to the public. However, shelter renters are welcome to use them during their reservation time.

RULES & REGULATIONS *(please read before calling the Town Hall with questions)*

1. Balloons and decorations are allowed, but please secure them properly to keep them away from the overhead fans. Should balloons or decorations get caught in or above the fans, please contact Public Works immediately at 919-614-8630.



2. Crockpots and heating trays with sterno cans are allowed. Please be sure to turn off crockpots and close sterno cans when not in use.



3. There are several trash receptacles on site. Large GFL units (black with green lids) are located near the bathrooms in the fenced in area. Additional metal trash receptacles are also located throughout the park. Please use the large GFL receptacles first until they are full.

4. The renter will not use the recreation space for a private profit-making enterprise.
5. The renter is renting the larger of the two park shelter spaces, not the park itself. The Community Park and smaller shelter space facing the playground (where the restrooms are located) will still be accessible to the public during the event.
6. No renters or persons affiliated with the renter's event will conduct themselves in a disorderly or obscene manner or commit any nuisance upon the grounds of any parks and recreation area.
7. No person will in no manner deface or injure any building, equipment, grounds, trees, shrubs, or plants growing in any of the parks and recreation areas or upon any premises under the jurisdiction of the Town of Wilson's Mills.
8. Persons using the park, field, and restroom areas are responsible for leaving the areas in the same condition as the beginning of their reserved event. This includes wiping down tables, cleaning restroom fixtures (if needed), and scraping clean the grill (if used).
9. All needs for cleaning up the bathroom facilities are the responsibilities of the renter.
10. Weapons of all kinds are prohibited on park property unless permitted by NCGS 14-415.23
11. No alcoholic beverages shall be brought upon or possessed or used in any of the parks and recreation areas.
12. Food/concession trucks are not allowed due to the park remaining open to the public during rental periods.
13. Bounce houses/inflatables and live animals (except for dogs on leash) are not allowed on the park grounds for any reason due to liability concerns.
14. Gambling is prohibited on or in any parks and recreation area or building except legally conducted and approved raffles operated by a recognized charity pursuant to state law.
15. No fire shall be lighted or made in any parks and recreation area except in the permitted grilling area enclosure provided.
16. It is unlawful for any person to ride any motor driven vehicle on the designated walking area of the park.
17. No person or group shall conduct activities on the parks and recreation grounds for the purpose of discriminating against a person or group.
18. Motor vehicles shall be parked only in designated parking areas.

19. In the event of inclement weather, the renter will have a choice of a refund or choice of another available rental day.

20. Payment is generally due 3 weeks before the scheduled event, unless request is made with less time prior to the event. Then payment will be due immediately. If payment is not received, the renter will lose their date of choice and not be able to rent the desired space.

How to Reserve the Shelter:

1. Check Availability - Visit our [Park Reservation Calendar](#) to see if your preferred date and time are available.
2. Submit a Request - Once availability is confirmed, complete the [Park Rental Request Form](#) to reserve your spot.
