Civil Penalty Fee & Nonpayment Penalty

<u>In addition</u> to the general penalties provided in the Town's Code, an ordinance may provide that a violation shall subject the offender to a civil penalty (G.S. 14-4). <u>The civil penalty is \$50.00</u>. <u>A nonpayment penalty of \$50.00 for each 30-day period</u> will be added to all civil penalties not paid by the date due.
